## LIBRARY RULES

1. **Viewing:** Any item in the Society's library can be viewed by prior arrangement with the librarian.
2. **Books on Loan:** Any member may borrow books for personal study for a period agreed with the librarian, normally up to three months. An exception to this being the Society's own publications. On request, and if convenient to the librarian, books will be taken to meetings for members to collect. Books may be returned in a similar way. Books may also be borrowed and returned by post, cost of postage each way to be paid by the borrower. Recorded delivery or registered post will be used depending on the value of the books. This can prove expensive and should be taken into account when requesting books in the post. Upon receipt of books in the post, the borrower must immediately return the advice slip together with the remittance for postage. Should the books be damaged in any way the librarian must be immediately informed in order that a claim can be made against Royal Mail. The wrapping must be retained to substantiate the claim. Any books lost or damaged whilst in a members possession must be paid for by the member. Books returned in the post must have adequate packing to prevent damage, any damage caused by failure to comply with this rule to be made good by the borrower, including the cost of replacing a damaged book should this prove necessary. Recorded delivery or registered post must be used as instructed by the librarian.
3. **Midland Mail:** A full set of the Society's journals are held in the Society's Library. These are not available on loan but can be viewed by arrangement with the librarian.
4. **The Society's other Publications:** One copy of the latest edition of each Society publication is held in the library. These are not available on loan but can be viewed by arrangement with the librarian.
5. **Photocopies:** Photocopies of any article in Midland Mail or any other publication in the Society's library can be supplied by the librarian. Exceptions to the above are photocopies from bound books which will not flatten without damage and from books produced by the Society – i.e. County sections, as it is to be expected that members will purchase complete Society publications. Rates of charges for photocopies based on each sheet photocopied, irrespective of the amount required on the sheet, will be published from time to time in Midland Mail. In order to comply with the Copyright Act it is essential that any photocopies supplied by the Society are for member's personal study and will not be reproduced in any way or passed on to any other person without the permission of the author of the book or article. Acceptance of photocopies to be on this understanding.
